Seasonal Contract

Between: Silver Creek Golf & RV Resort ("The Park")

-and-

("The Guest")

Recitals:

Whereas:

1. The Park is in the business of operating a 27-hole golf course, and leasing out recreational camping lots;
2. The guest wishes to lease a seasonal lot from the park;
3. Both parties have a common interest in ensuring that all guests have a pleasant stay;

It is Agreed That:

1. The Park will provide certain facilities at the prices set out in the attached Rate Sheet.
2. The Park will enforce the Rules set out in the attached Schedule "A"
3. The Guest will pay all fees owed to the park when due.
4. The Guest will abide by all the Rules set out in Schedule "A".
5. The Park shall have the unfettered discretion to determine whether the Guest has breached any of the Rules.
6. The Guest agrees that, in the case of a breach of the Rules the Park may immediately terminate this contract.
7. The Guest may not transfer this contract without the prior written consent of the Park.
8. The Guest shall be legally responsible for all damage to the Park's property caused by the Guest or any visitor of the Guest.
9. The Guest undertakes to carry general liability insurance for trailers and golf carts.
10. The Park shall be legally responsible for all damage to the property of Guests and Guests' visitors caused by the Park and its employees acting with in the course of their duties with the Park. The Park will not, however, be responsible for property damage caused by act of God, acts of the Park's employees falling outside their duties of employment, or the torturous or criminal acts of third parties.
11. The Park agrees to recognize the following cycles of season:
 - A. The summer operating season, which runs from Mid-April to Mid-October.
 - B. The winter storage season, which runs from Mid-October to Mid-April.
12. A. Provided that the Guest pays in full, the fees owed, no later than April 15. (weather conditions will be taken into consideration)
13. Should the Guest fail to pay the fall deposit by October 31 or the summer fees by April 15, the Park, with notice to the Guest, will remove the trailer from the lot until such fees are paid.
14. ***This contract shall take effect as of November 1st or once it has been signed by both parties and shall terminate on October 31 of each year. (NEW CONTRACT DATES)***
15. The park has the absolute right to amend the Rules and Regulations (Schedule "A") as it deems reasonable, provided however the Park provides notice to the Guest of all amendments.
16. ***A \$500.00 non-refundable deposit, due by October 31st, is required of each guest wishing to return for the next season. If the deposit is not paid it will be assumed that you are not returning, and your lease will be terminated. You will then be required to remove your trailer from the lot. Note: the trailer must be removed by November 1 or a 25.00/day late fee will be charged.***
17. ***If you choose not to renew for the next season, you will need to fill out our Site Refusal Form and remove your trailer as of November 1st.***

Silver Creek Golf & RV Resort Rules & Regulations

Schedule A

1. **Advertising and Sale:**
"For Sale" Signs are not permitted within the Park, nor shall the Park's name be used in connection with any advertisements for sale.
2. **Damaged Lot:**
Site holder is responsible for all damages incurred on their lot, including but not limited to, damage done to grass or trees, as well as damaged pedestals or sewer pipes which are struck in the move in or out process. Any damage must be reported and replaced as soon as possible following the incident.
3. **Entry and Use of Facilities:**
The Park reserves the right to:
 - a. Determine who may and who may not enter the Park
 - b. Control who may use which facilities
 - c. Eject any Guests or visitors who, in the opinion of the Course, are undesirable.
4. **Fires:**
Fires are permitted, provided that they are contained in a portable fire safe container and are subject to local municipality fire bans.
5. **Golf Carts:**
 - a. There will be a 600.00 tracking fee for the use of the golf cart within the Park. Please do not lend out your cart to people other than your immediate family. If you do lend your cart out, **you or the operator is required to pay a tracking fee.** If one is not paid, the fee will be charged to your account.
 - b. The use of the golf carts must follow all Course rules and are restricted to Park roads when not on the course. A valid driver's license is required to operate a golf cart. The number of persons on a golf cart must be limited to the seating capacity.
 - c. The only people who are permitted to operate the power cart is yourself, spouse and children 16+. You are required to show the tracking tag on your cart provided to you by the Park.
 - d. **Please respect course rules when operating your cart, stay off berms, stay on cart paths where provided.**

***The Tracking Fee is valid for ONE cart only!
6. **Motorized Personal Vehicles:**
Mini-bikes, skateboards, All-Terrain Vehicles, Quads, Trikes, Argos, etc. are not permitted to be operated with in the Park.
7. **Noise:**
 - a. Quiet time is from 11:00 PM to 7:00 AM
 - b. At all times Guests are required to keep noise to a level that will not disturb other users of the Park.
8. **Site Information**
 - a. Only 1 RV Units is permitted per site.
 - b. Only store items pertaining to your campsite, such as BBQ's, Patio Furniture etc.
 - c. Any constructed shed must be approved by management. No shed for power cart storage is to be constructed.
 - d. Any site construction, Decks, Privacy fences or Silver Creek Rooms may only be constructed with Park's permission, and a set of building plans must be provided.
 - e. The site is to be kept in a neat and clean state; this included mowing the lawn areas around the site. If sites are required to be maintained by Park staff and minimum 50.00 charge will be levied.
 - f. Clotheslines are not permitted, nor shall laundry be hung up outside the recreational vehicle.
 - g. All shrubs, trees, sod, decks, fences and Silver Creek Rooms etc. become and remain property of Silver Creek Golf & RV Resort.
 - h. Trees cannot be cut down without permission.
 - i. Site are not to be subleased, during the season. If you have Visitors coming in for the weekend, please book a site at the Proshop.
9. **Pets**
 - a. When outside the recreational vehicle, pets must always be attended and leashed. At no time may pets run loose in the Park.
 - b. Pets are not permitted in washrooms, Clubhouse/Patio or Tournament House.
 - c. Noisy, unruly or dangerous pets will not be permitted to remain in the Park
 - d. Please clean up after your pet at all times. \$50.00 will be charged for the first incident, the second incident will require the removal of your pet.

10. Removal of Recreational Vehicle:

- a. In the absence of notice to the contrary, the Park is entitled to assume that the removal of a Guests' recreational vehicle amounts to an abandonment of site and a termination of the contract by the Guest. If the Guest does not intend to terminate the contract, care should be taken to advise the Park of the Guests' true intentions.
- b. If the October Deposit of \$500.00 is not paid, the Guests' lease will be terminated.
- c. **Guests who are pulling out, must have their trailer removed by November 1.** A late fee of \$25.00 per day will be charged after this date, unless other agreements have been made with the Park management.

11. Sewer Hook-Ups:

All sewer hook-ups must be watertight and sealed to meet health codes.

12. Storage

Storage of any other trailer other than the trailer already registered is only permitted with prior permission from the Park and will be charged \$75 per month from April-October, and \$250 total for the winter storage season.

13. Traffic

The speed limit in the Park is 15km/hour. Pedestrians have the right of way at all times. Repeated violation will be deemed sufficient cause for the park to deny any Guest the privilege of operating a motor vehicle within the Park.

14. Trash:

- a. Containers are provided throughout the Park.
- b. Provincial Landfills are continually limiting the amounts and types of waste, requiring all of us to recycle whenever possible, your cooperation is appreciated.
- c. **Please break down all your cardboard boxes. We have provided a yellow recycle bin up at the clubhouse.**
- d. Please bag your leaves and keep them at your site for our staff to come and pick them up.
- e. West Dried Meat Lake Landfill hours of operation are Monday-Saturday 8:45 AM-3:15 PM, please take all Metal, Wood, BBQ's, lawn mowers and mattresses, as well as any other building materials to the landfill. Please DO NOT put them in the dumpsters.

15. Tee Time Bookings

- a. When booking your tee-times you have access to a 10-day advance booking ONLINE ONLY. As a member, you can login to our booking system and manage all your tee-times. You can Add, Edit and Delete tee-times all from your home computer or mobile device. If you choose not to book your tee-times online then you can call in the Monday before the weekend. If you have any problems with Online Booking, please come and see us and we will get you set up correctly.
- b. There are tee-times set aside for members both online and call in,
- c. We try our best to rotate the course accordingly. Please respect that and not jump onto a different course without first checking with the Pro-Shop Staff or Course Marshalls, as there may be tournaments or course maintenance scheduled.
- d. **Please add in the names of those golfing with you. If you have repeated no shows, they will then be charged to your accounts.**

16. Memberships

- a. Seasonal Campers are required to purchase one full membership or two restricted memberships, there are no exceptions to this, and punch cards cannot be used as a substitution.
- b. Memberships once purchased are not transferable. If there are medical reasons for which you are unable to use your membership, please contact management and each situation will be dealt with individually.

17. Member Accounts

As a member, you have access to an account where you are able to charge things both in the Kitchen and Pro-shop. We require that you clear the account at the end of each month. If your account is not cleared, a 3% interest fee on the balance, per month, will be charged until it is paid in full.

18. Internal Moves

- a. If you are interested in an internal move, you must complete the Internal Move Form, please ask for one at the Pro-shop. Your form will then be added to the internal move list. You will then be contacted in the order your form was submitted and will only be contacted for the sites you have listed on your form. Just because you have a site listed and it comes available does not guarantee that you will get it, as there could be someone on the list ahead of you who has also selected that site.
- b. There is an Internal Move Fee of \$500.00 and is to be paid in full before moving into your new site.

19. Site Transfers (Trailer Sold on Site)

- a. Site transfers can only be done, if approved and you have written permission from management, and the site transfer form has been completed.
- b. Site transfers are subject to a \$500.00 administration fee.
- c. You must still abide by the rules set out in Section 1 "Advertising and Sale"
- d. Memberships are not transferable. Memberships are required for those choosing to lease a lot.
- e. Silver Creek Management reserves the right to deem whether a person is suitable for a lease. So please come and see us first before committing to sell your trailer.

***Restricted & 9 Hole Memberships** – Monday to Friday, Sundays and Holidays after 3pm. If you choose to play on weekend or upgrade to 18 holes you are required to pay a \$10 upgrade fee.

****Tracking Fees** apply to the use of one cart, and can only be operated by yourself, spouse and children over the age of 16 who have a valid Driver's Licence, or immediate family members.

***** Cart Shed** - Prices include your tracking fees for the season

******Full Power Cart Rental** is the use of one of our carts on the course for the season. With this you can use both seats on the cart and no extra cost if you bring a guest. This cart is still property of Silver Creek Golf Course, and you are required to bring your cart back after your round. You can not lend out your cart to other guests.

******* Half Power Cart Rental** is the use of one of our carts on the course for the season. With this you are only entitled to one seat on the cart, if you bring a guest along with you, they still are required to pay for a seat on the cart. This cart is still property of Silver Creek Golf Course, and you are required to bring your cart back after your round. You can not lend out your cart to other guests.

*******New for 2020** – Those who are renting a yearly cart are now required to fill out the yearly cart rental form.

If you are using MasterCard or Visa, there is a 1.5% charge on the total at the till and a 3% charge on the total that is paid over the phone.

Power for the 30-Amp Sites are metered and will be billed out at the end of the season. These bills are placed on your account

Your \$500.00 non-refundable deposit, paid by October 31, is subtracted from your final bill due in March

All Fee's will be applied to your account. Those that are not cleared up by April 15, will be subject to a 3% interest charge on the balance.
